The services shall perform following NBP' s activity to comply with the related rules, regulation and customers' requirements as follows:

- 2) Safe navigation and management for the Heavy Lift and RORO vessels
- 3) Safe Heavy Lift and RORO Heavy cargo operations

**0.1 Quality Policy :**

- 4) We ensure that personnel skill and knowledges concerning Heavy Cargo Transport Department shall be required to comply with this quality policy and processes with their awareness.

**3) Manage Emergency preparedness and Response:**

We have established, implemented and maintained process(es) needed to prepare for and respond to the potential emergency situation.

We shall manage to prepare against serious accidents and emergencies, and establish occupational health and safety activities with the ultimate goal of maintaining zero major accidents and zero accidents for the safest HSE Management System.

**4) Communication and Participation of workers:**
