## History of NYK-Hinode Line

### November 1912

Hinode Kisen was established in Nihombashi, Tokyo, with paid-in capital of 500,000 yen and four ships.

### April 1964

The company became part of the Showa Line Group as a result of a consolidation of shipping companies.

### October 1998

The company became part of the NYK Group as a result of a merger between NYK Line and Showa Line.

### February 2001

The company became a wholly-owned subsidiary of NYK Line through a share exchange program.

### July 2002

The company changed its name to NYK-Hinode Line Ltd. and become a conventional vessel operator within the NYK Group.

### September 1988

Toho Shipping Co. Ltd. was established in Shintomi-cho, Chuo-ku, Tokyo, with paid-in capital of 100 million yen. Over 18 handy bulk vessels were taken over from Shinto Shipping Co. Ltd., and American and Canadian log transport operations were started.

### December 2001

The company became a wholly owned subsidiary of NYK Line.

### October 2002

The company inherited handy bulk vessel operations from NYK Line.

### November 2002

The company changed its name to NYK Global Bulk Corporation.

**NYK-Hinode Line Ltd. and NYK Global Bulk Corporation merged to become NYK Bulk & Projects Carriers Ltd.**
